

PhillipMart Announces Pre-IPO Share Price of JS Global Lifestyle Company Limited (Stock code: 1691)

(Hong Kong – 17 Dec 2019) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of JS Global Lifestyle Company Limited ("JS Global Lifestyle"; stock code: 1691) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for JS Global Lifestyle on PhillipMart were HK\$5.27 and HK\$4.89. The price closed at HK\$5.2 per share, which same as its offer price of HK\$5.2. The price opened at HK\$5.2, with the most actively traded price of HK\$5.2 per share, and a turnover of 1,128,500 shares. The total trading volume reached 3,951,000shares with **total turnover of HK\$20,149,955**. The final price of JS Global Lifestyle, to debut trading tomorrow has been fixed at HK\$5.2 per share.
