

PhillipMart Announces Pre-IPO Share Price of Tailam Tech Construction Holdings Limited (Stock code: 6193)

(Hong Kong – 17 Dec 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Tailam Tech Construction Holdings Limited ("Tailam Tech"; stock code: 6193) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Tailam Tech on PhillipMart were HK\$1.82 and HK\$1.56. The price closed at HK\$1.71 per share, 31.54% higher than its offer price of HK\$1.3. The price opened at HK\$1.57, with the most actively traded price of HK\$1.75 per share, and a turnover of 422,000 shares. The total trading volume reached 3,858,000shares with **total turnover of HK\$6,618,360**. The final price of Tailam Tech, to debut trading tomorrow has been fixed at HK\$1.3 per share.
