

PhillipMart Announces Pre-IPO Share Price of POLY PROPERTY DEVELOPMENT CO., LTD. (Stock code: 6049)

(Hong Kong – 18 Dec 2019) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of POLY PROPERTY DEVELOPMENT CO., LTD. ("POLY PROPERTY DEV"; stock code: 6049) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for POLY PROPERTY DEV on PhillipMart were HK\$40.9 and HK\$37.8. The price closed at HK\$40.25 per share, 14.67% higher than its offer price of HK\$35.1. The price opened at HK\$37.8, with the most actively traded price of HK\$40 per share, and a turnover of 1,742,200 shares. The total trading volume reached 11,721,200 shares with **total turnover of HK\$468,247,810**. The final price of POLY PROPERTY DEV, to debut trading tomorrow has been fixed at HK\$35.1 per share.
