

PhillipMart Announces Pre-IPO Share Price of Times Neighborhood Holdings Limited (Stock code: 9928)

(Hong Kong – 18 Dec 2019) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Times Neighborhood Holdings Limited ("Times Neighbor"; stock code: 9928) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Times Neighbor on PhillipMart were HK\$5.5 and HK\$5.14. The price closed at HK\$5.15 per share which same as its offer price of HK\$5.15. The price opened at HK\$5.5, with the most actively traded price of HK\$5.3 per share, and a turnover of 757,000 shares. The total trading volume reached 3,581,000 shares with **total turnover of HK\$18,785,560**. The final price of Times Neighbor, to debut trading tomorrow has been fixed at HK\$5.15 per share.
