

**PhillipMart Announces Pre-IPO Share Price of
 Bank of Guizhou Co., Ltd. (Stock code: 6199)**

(Hong Kong – 27 Dec 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Bank of Guizhou Co., Ltd. (“Bank of Guizhou”; stock code: 6199) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Bank of Guizhou on PhillipMart were HK\$2.48 and HK\$2.37. The price closed at HK\$2.43 per share, 2.02% lower than its offer price of HK\$2.48. The price opened at HK\$2.48, with the most actively traded price of HK\$2.43 per share, and a turnover of 843,000 shares. The total trading volume reached 2,482,000shares with **total turnover of HK\$5,996,380**. The final price of Bank of Guizhou, to debut trading at 30 Dec. It has been fixed at HK\$2.48 per share.
