

**PhillipMart Announces Pre-IPO Share Price of
 Taizhou Water Group Co., Ltd. (Stock code: 1542)**

(Hong Kong – 30 Dec 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Taizhou Water Group Co., Ltd. (“Taizhou Water”; stock code: 1542) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Taizhou Water on PhillipMart were HK\$4.34 and HK\$4.22. The price closed at HK\$4.28 per share, 1.42% higher than its offer price of HK\$4.22. The price opened at HK\$4.26, with the most actively traded price of HK\$4.22 per share, and a turnover of 405,000 shares. The total trading volume reached 814,000shares with **total turnover of HK\$3,443,740**. The final price of Taizhou Water, to debut trading tomorrow. It has been fixed at HK\$4.22 per share.
