

PhillipMart Announces Pre-IPO Share Price of Wise Ally International Holdings Limited (Stock code: 9918)

(Hong Kong – 9 Jan 2020) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Wise Ally International Holdings Limited ("Wise Ally Int"; stock code: 9918) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Wise Ally Int on PhillipMart were HK\$0.28 and HK\$0.211. The price closed at HK\$0.238 per share, 4.8% lower than its offer price of HK\$0.25. The price opened at HK\$0.28, with the most actively traded price of HK\$0.25 per share, and a turnover of 4,528,000 shares. The total trading volume reached 37,568,000shares with **total turnover of HK\$9,137,024**. The final price of Wise Ally Int, to debut trading tomorrow has been fixed at HK\$0.25 per share.
